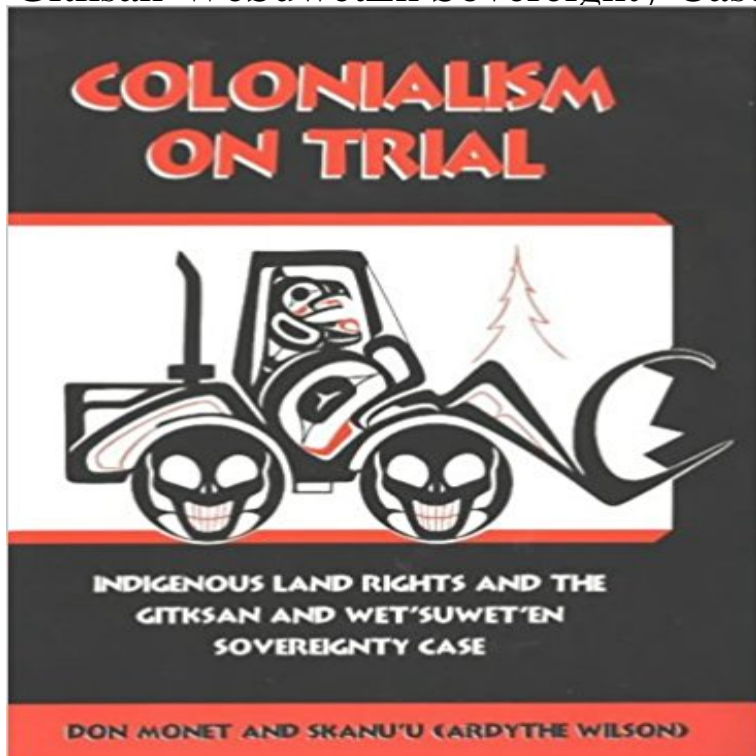


# Colonialism on Trial: Indigenous Land Rights and the Gitksan-WeSuwetEn Sovereignty Case
