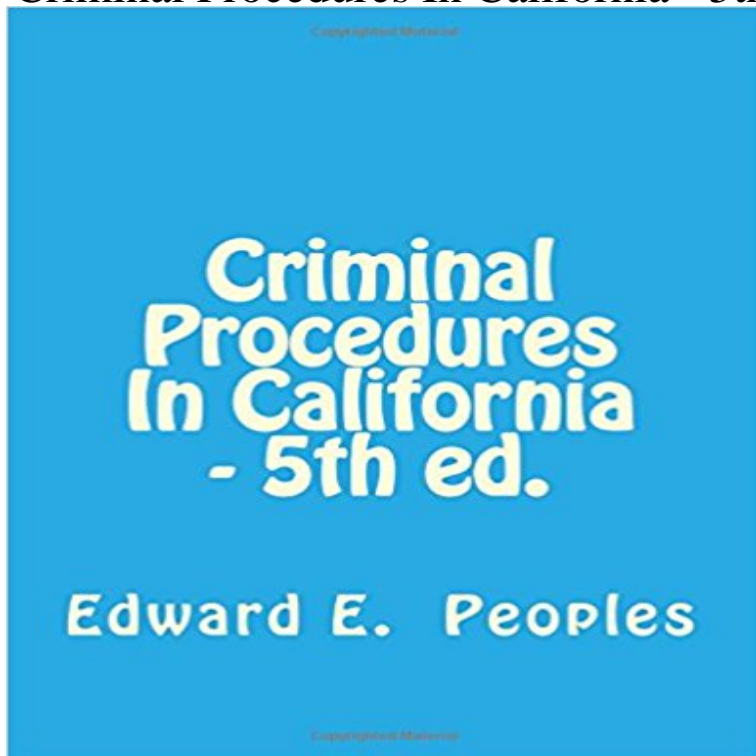


## Criminal Procedures In California - 5th ed.
