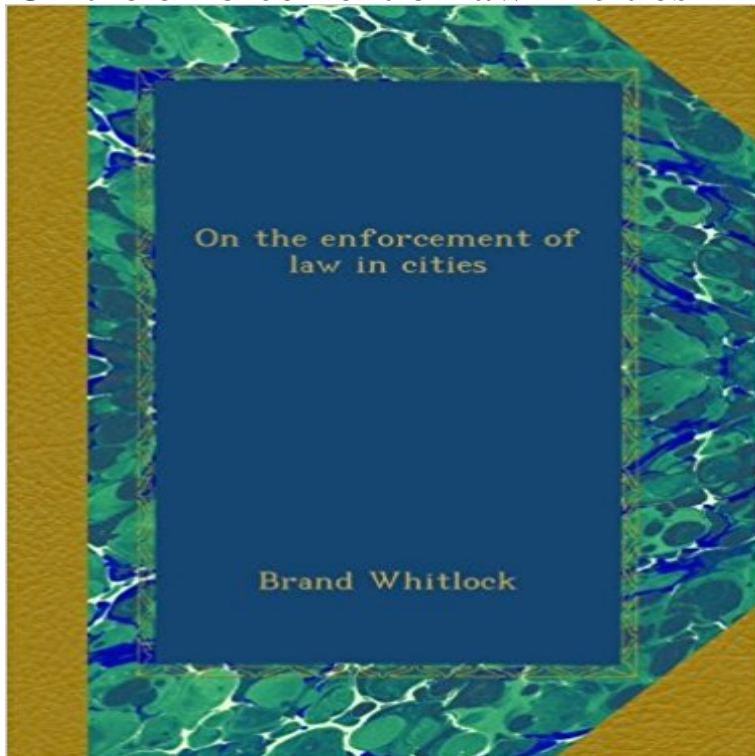


On the enforcement of law in cities
