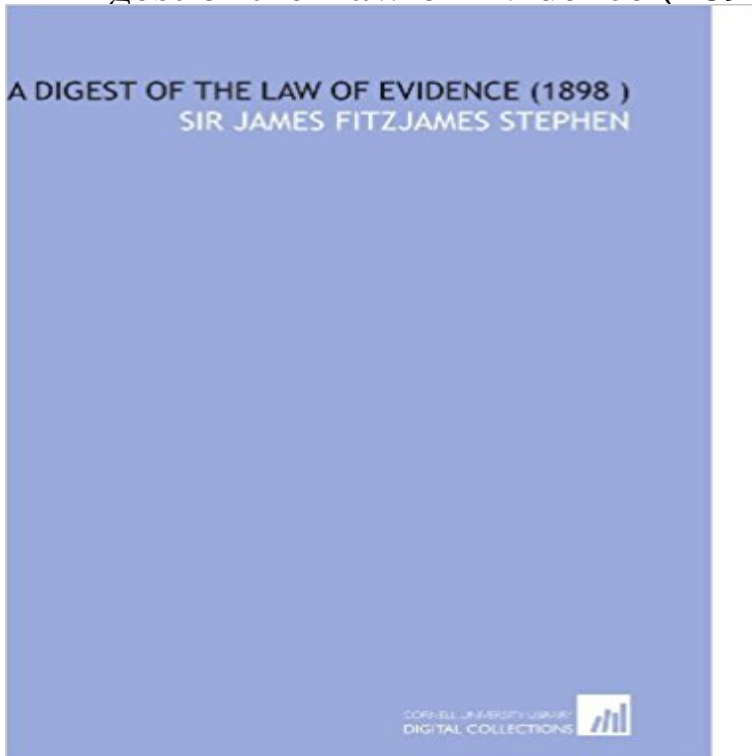


A Digest of the Law of Evidence (1898)
