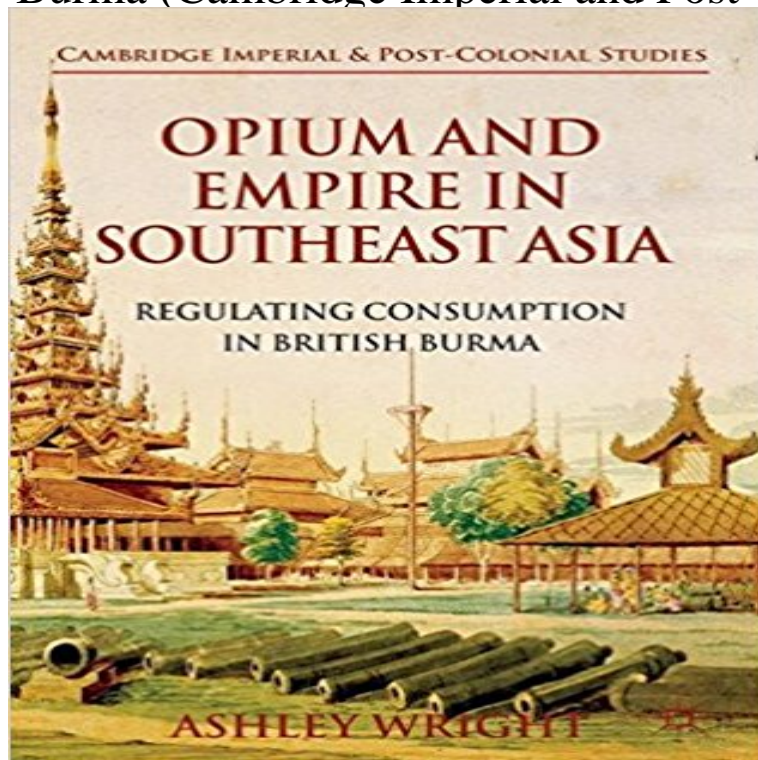


## Opium and Empire in Southeast Asia: Regulating Consumption in British Burma (Cambridge Imperial and Post-Colonial Studies Series)
