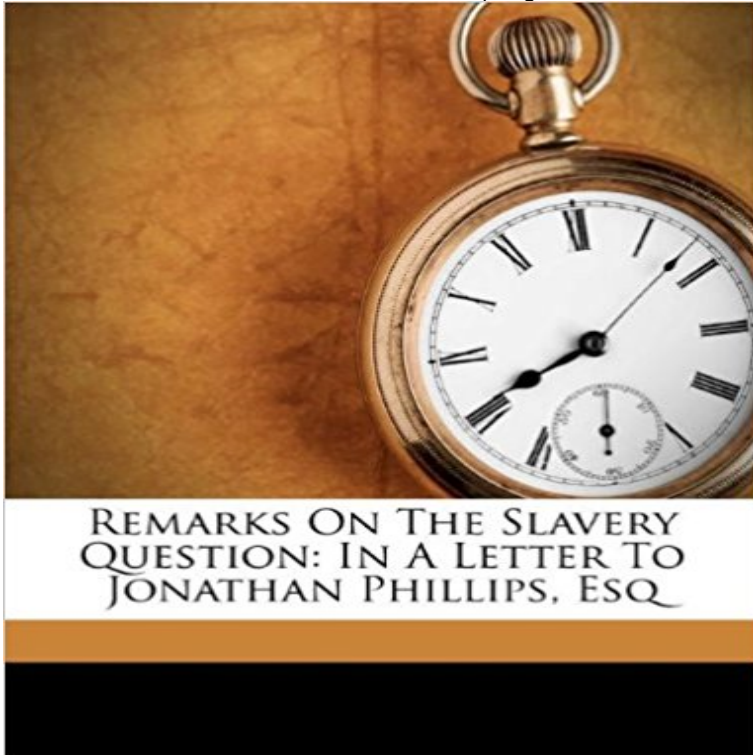


# Remarks On The Slavery Question: In A Letter To Jonathan Phillips, Esq
