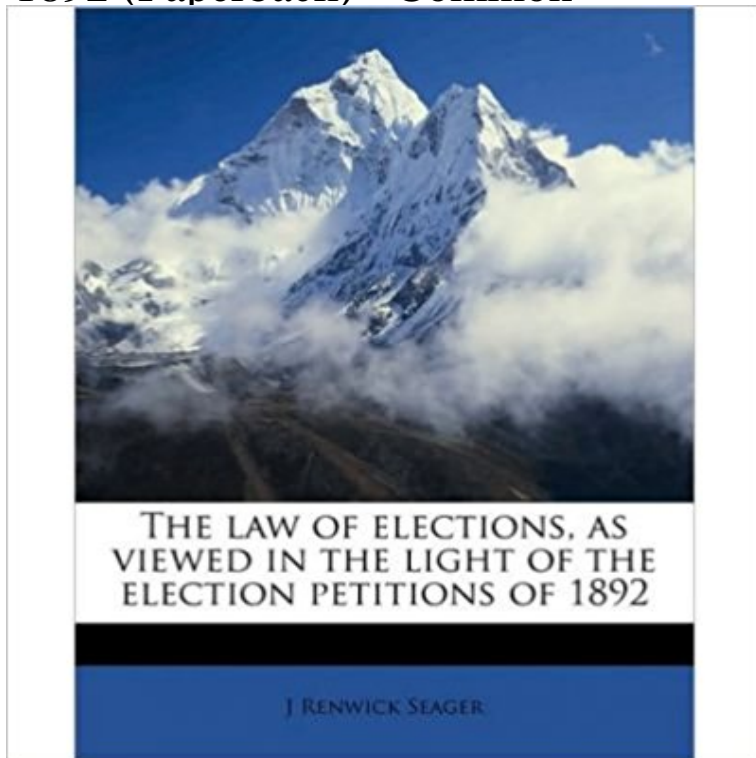


## The Law of Elections, as Viewed in the Light of the Election Petitions of 1892 (Paperback) - Common
