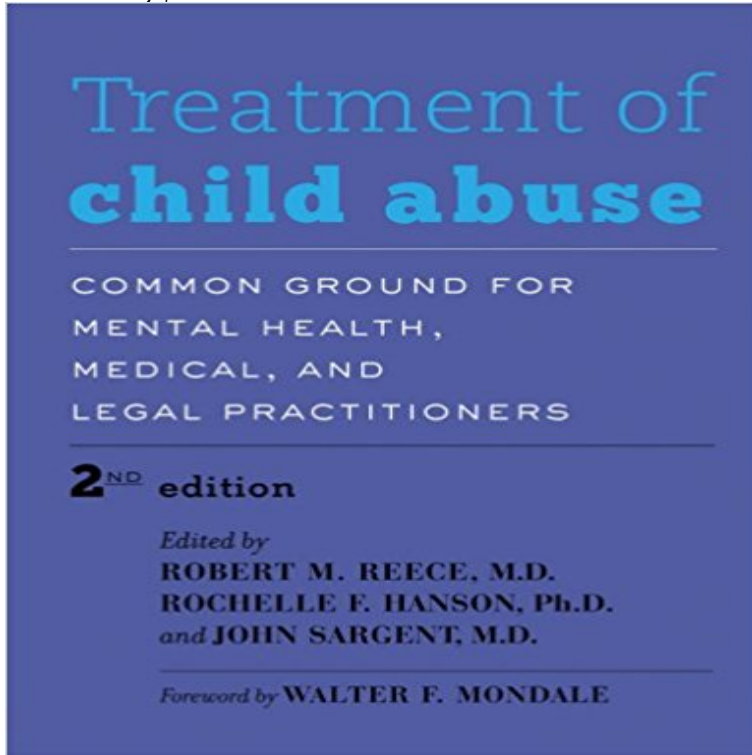


# Treatment of Child Abuse: Common Ground for Mental Health, Medical, and Legal Practitioners
