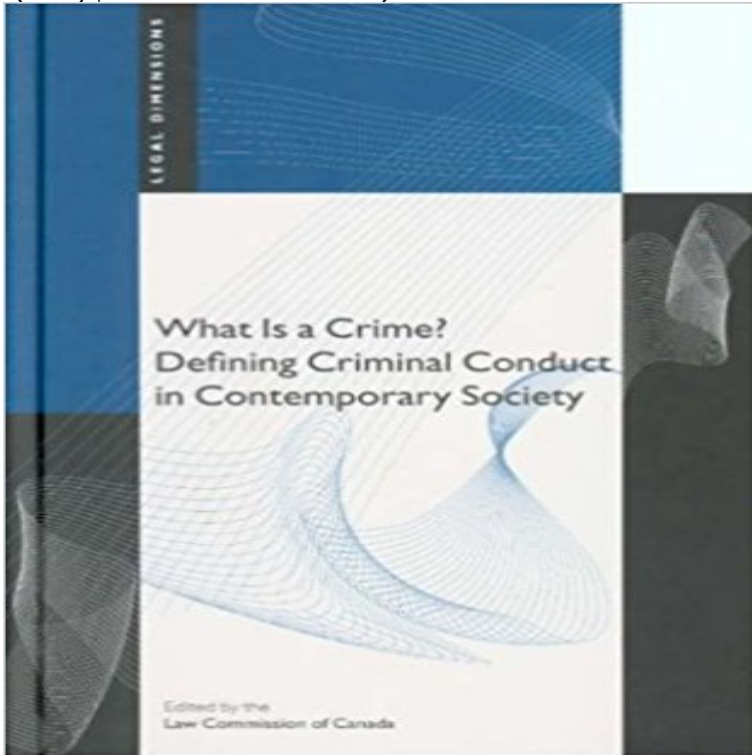


## What Is a Crime?: Defining Criminal Conduct in Contemporary Society (Legal Dimensions)



We all have notions of what it means to commit a crime. Most of us are very much aware of the behaviours which, by law, constitute crime. Rarely, however, do we stop to consider why certain activities and behaviours are deemed criminal and others are not. A brilliant and provocative volume, *What Is A Crime?* forces us to reconsider both how we define criminal conduct in contemporary society, and how we respond to it once it has been identified. Collectively, the authors provide a critical dialogue on law and governance in contemporary society. *What Is A Crime?* will be of interest to a broad spectrum of readers with an interest in the governance of crime and its control in contemporary society. Students and scholars of law, sociology, political science, philosophy, and criminology will find this book invaluable in furthering their understanding of the processes of defining and responding to crime and criminal behaviour. It will also hold sway with policymakers, criminal justice practitioners, and anyone with a stake in our current approaches to crime.
